## Background:

The AP&P committee found that course proposals involving changes in course prefix, course number, units, and course titles were not reflected in the respective program outlines. As a result, these discrepancies cause issues with student program completion and delay attainment of academic and career goals.

#### Proposal:

The AP&P committee proposes that course modifications involving the prefix, number, title, and/or units must be submitted with corresponding program modifications for all programs in which the course is required (core, elective, or selective). This may necessitate faculty in other disciplines to submit program modifications if the course is not in the same discipline.

#### Discussion:

- Modifications in the course prefix, number, title, and units impact the program/s outlines. CurriQunet
  automatically changes the course prefix, number, and title. These have no effect on the total number of
  program units. However, only changes in the units may affect the program. For instance, selected units and
  electives may not affect the total number of units in the program.
- Discrepancies in the course units in programs undergoing revisions. The counselling department may initiate a temporary unit-waiver as a short-term fix while the program changes are underway.
- Delays of committee action on course proposals that affect the programs. The committee continues to review these course proposals that impact the program/s and would decide on a case-by case basis regarding the impact of the course in one or more programs.
- Recommendation: Continue discussion regarding the need to establish committee policy and procedure regarding concurrent submission and review of courses impacting program/s.

Major Modification	PHYS 161	Engineering Physics 1 Justification: Updating units to reflect the appropriate level of workload required for the course. Previously the units assigned were 3 lecture hours plus four lab hours. In practice, the 4th lab hour was to be used as a discussion hour. Unfortunately, this implies only 5 hours of work were allowed for outside of class. Furthermore, using the 4th lab hour as a as a discussion hour (instead of a lecture hour) mis-represents the actual usage of the extra hour. I can provide a detailed breakdown of every minute I spend on topics over the course of the semester (I have the XL file typed up already). The net result is an undue burden on students for the number of units requested. When you compare this to my Phys 162 & Phys 163 courses, you will see the extra hour is needed as lecture to cover the material properly. Students have repeatedly made unsolicited comments about the workload outside of class being incompatible with the number of units assigned. About 2/3 of students surveyed have requested we reinstate our lost unit. The other third is mainly ambivalent about the change. Most of our students prefer the extra unit being there since it allows them to reach full time status with one less course while taking this course.  IN SUMMARY: We need to convert that supplemental lab hour (discussion hour) back to a lecture hour and up the number of units by 1. The extra unit used to be lecture, we tried to make it work as a discussion/lab hour, the experiment failed.  Note: You will be told this negatively impacts funding for the college in relation to Chemistry degrees. Please keep in mind the Organic Chemistry course can reduce by 1 unit to offset our increase by 1 unit without affecting college funding if this is an issue. There is no valid reason for continuing to decrease the probability of physics student success by keeping these units suppressed at a lower than realistic level.	5.000

## **Current Practice:**


Proposals are assigned to faculty for review based on department, discipline assignment, and the roles assigned in CurriQunet.

Noncredit courses and programs are routed to community education levels of approval. Community Education, as a department, does not have adequate number of full-time faculty to have AP&P Committee representation. Also, there is no designated department chair position.

The noncredit courses and programs are proposed by both credit and noncredit faculty. The proposal is then reviewed by the technical review committee (TRC) and then by the community education dean, followed by AP&P review. With increasing numbers of new noncredit proposals, a review process that includes appropriate faculty review is needed.

### Proposal:

- Discipline faculty identify noncredit courses and programs (disciplines) that would be within the purview of
  the respective disciplines. The discipline faculty and the respective faculty in noncredit would be designated
  to review noncredit courses and programs at the department chair level.
- The academic dean, community education would review noncredit course and program proposals.



The above proposal was reviewed and approved by the Board of Trustees on June 9, 2020.


Next Steps: Review and modify BP/AP 4400 Community Education Programs. Develop an approval process for noncredit (community) education as described in the BP/AP 4400.

#### Definitions:

- Noncredit Dean the academic dean for noncredit courses and programs
- Noncredit Representative the noncredit faculty expert on noncredit curriculum.
- Noncredit coordinator oversees all noncredit courses and programs approvals.
- Discipline Faculty and Discipline Chair refer the credit disciplines involved or impacted by the noncredit proposal. NOTE: The initiator's assigned discipline determines the involved disciplines in the noncredit proposal approval process.



#### **Recommended Noncredit Course Prefixes**

- The current course prefixes and 7000-level numbering remain. They are based on the approved noncredit categories.
- The discipline faculty noncredit course-program initiator may use: (1) a credit course prefix with a 7000-course number; or (2) a new noncredit prefix that is similar but not the same as the credit prefix with a 7000-course number.
