### ALLAN HANCOCK COLLEGE FOUNDATION FINANCE COMMITTEE MEETING Minutes of October 16, 2019

A regular meeting of the Finance Committee was held on Wednesday, October 16, 2019, at 1:00 PM at Allan Hancock College, 800 South College Drive, Bldg. B – Captain's Room, Santa Maria, California.

#### Call to Order

The meeting was called to order at 1:02 PM by Committee Chair Glenn Owen.

#### Roll Call

Finance Committee members present: J. Frost G. Owen, E. Smith

#### **Public Comment**

There were no requests from the public to address this meeting.

#### Approval of Agenda

Chair Owen asked the committee to review the agenda for today's meeting and called for a motion to approve the agenda.

<u>MOTION</u>: On a motion by Director Smith, seconded by Director Frost, the agenda was approved as submitted.

#### **Approval of Minutes**

#### Minutes of July 10, 2019

Chair Owen asked the committee to review the minutes of July 10, 2019, and called for a motion to approve. There was one amendment submitted by Director Frost. On page 2, Review and Approval Investment Policy, "Mr. Todd McGinley recommended allowing high yield funds bonds".

**MOTION**: On a motion by Director Smith, seconded by Director Frost, the minutes of July 10, 2019 were approved as amended.

#### **Review and Approval of Financial Statements**

Chair Owen presented the following financial statements to the committee:

Check Registers - 5/31/2019, 6/30/2019

*Contributions Report* – For the period of 7/31/2018 through 6/30/2019, the total contributions were \$1,646,016.

Banner Finance Statement of Operations: For the period ending 6/30/2019, the fund balance for the period was \$27,303,757.

Banner Finance Statement of Financial Position: For the period ending 6/30/2019, the total liabilities and fund balance were \$27,881,259.

Banner Finance Foundation General Operations: The budget dated 6/30/2019, the revenue for the fiscal year as \$394,060; the expenses as \$379,766; the ending fund balance as \$14,294. Noted was the Revenue Account Intrafund Transfer-In with a year to date total of \$205,797 which includes Administration Fee from endowments @ 1.5%, amount \$87,895; President's Circle Campaign @ 15%, amount \$7,360; Young Endowment Proceeds, amount \$87,190; Unrestricted endowment proceeds, amount \$3,650; Hancock Promise gift fee @ 1.5%, \$3,602 and Hansen Unrestricted Endowment, amount \$16,100.

AHC Financial Overview – General Operations: The Financial Overview budget dated 6/30/2019, reported total actual support and revenue as \$342,808; total actual expenditures as \$379,766; and total liabilities and net assets as \$158,294.

AHC Financial Overview – All Foundation funds: The Financial Overview statement dated 6/30/2019, reported total contributions and support as \$1,646,016; total expenditures as \$1,812,841; and total liabilities and net assets balance as \$27,881,260.

AHC Foundation Financial Overview – Investments: As of 6/30/2019, the cash balance is \$1,768,852, investment balance of \$25,441,059, and total assets were \$27,881,260.

**MOTION**: On a motion by Director Frost, seconded by Director Smith, the Finance Committee approved the financial statements as submitted.

#### **Endowment Challenge Title III Grant & Review of Endowment (ACTION)**

Staff received a letter dated October 3, 2019, from Dr. James E. Laws, Jr., Division Director, of the U.S. Department of Education, stating the Foundation has been released from the U.S. Dept. of Education Challenge Title III Grant as of September 30, 2018.

The committee reviewed a listing of Title III and NonFed Title III endowment values as of June 30, 2019. The designation for three of the endowments are for the PCPA Foundation and named *PCPA Forever! Scholarship Endowment, Sesto/Severo Endowment*, and *Walter Conrad - PCPA Endowment*. The committee agreed the funds can be disbursed to PCPA Foundation.

Endowments without fund agreements will designated for the unrestricted fund includes *Bank of Santa Maria, Title III Technology, Title III Unrestricted and Title III Program Enhancement.* 

<u>MOTION</u>: On a motion by Director Smith, seconded by Director Cox, the Finance Committee approved disbursing the Title III endowments designated for PCPA Foundation - *PCPA Forever! Scholarship Endowment, Sesto/Severo Endowment*, and *Walter Conrad - PCPA Endowment*. Director Frost abstained.

#### **Sustainability Plan Update (INFORMATION)**

Mr. Hooten reported to the committee an update to the Foundation's operating budget sustainability plan. At issue is the amount of annual drawdowns from the Young and Hansen quasi endowments to balance the budget each year. The Finance Committee requested staff develop an analysis and projection of the Foundation's financial position and provide a recommendation to reduce dependence on reserves.

The 2019-20 Allan Hancock College annual budget, approved by the Trustees at the September 2019 meeting, includes \$123,000 for direct operational support to the Foundation. The district's multi-year budget plan includes direct operational support for the next three years, totaling \$369,000. Development of an MOU between the Foundation and district is needed to detailing the information the agreement is in progress.

Further, the Foundation received notification of a release from the Title III grant. The 2019-20 general operations has budget approximately \$21,500 for Title III endowment funding and brokerage fees expenses---a significant savings to the budget.

Mr. Hooten stated the district support will substantially decrease the funds needed from the unrestricted Young and Hansen quasi endowments over the next three years and limit drawdowns allowing the endowments to regain some value. Further, Mr. Hooten mentioned once the Hancock Promise campaign is completed, the Foundation will begin a strategy for aggressively soliciting unrestricted operating dollars through an annual fund campaign.

#### **Discussion of Multiple Investment Advisors (INFORMATION)**

The Foundation presently holds investments at five different investment firms – Morgan Stanley, Monarch Wealth Strategies, Northern Trust, Mechanics Wealth Management and Santa Barbara Foundation. The Committee will discuss reducing the amount of investments after the January investment annual review. Staff will provide further investment information detailing the pooled endowments at the next meeting.

#### **Discussion of Continuing Investment Advisors Annual Review (INFORMATION)**

The past two years the investment advisors from Morgan Stanley, Northern Trust, Monarch Wealth Strategies, Mechanics Wealth Management and Santa Barbara Foundation have presented annual portfolio reviews to the committee. The committee requested staff schedule the advisors for a 20-minute review on Wednesday, January 15, 2020.

#### **Next Finance Committee Meeting**

The next scheduled meeting of the Finance Committee is Wednesday, January 8, 2020, at 1:30 PM, in the Captain's Room located in Building B at the Allan Hancock College Campus in Santa Maria.

#### **BACKGROUND**

Allan Hancock College's approved 2019-20 annual budget includes \$123,000 for direct operational support to the AHC Foundation. The district's budget plan includes \$369,000 in support to the Foundation over the next three years. An MOU between the district and foundation is in the process of being drafted.

The attached revised 2019-20 General Operations Budget increases the *District/Grant Contribution* from \$65,611 to \$188,611. A budget decrease to *Intrafund Transfer In* from \$255,634 to \$133,059. The decrease to *Intrafund Transfer In* represents decreasing transfers in from the unrestricted Young and Hansen Endowments.

#### RECOMMENDATION

The Finance Committee recommends approval of the revised 2019-20 General Operations Budget as submitted. If approved, the revised budget will be forwarded to the Executive Committee and full board for review and approval at the annual organizational meeting scheduled on January 23, 2020.

#### **BACKGROUND**

Each year the Finance Committee develops and approves a proposed operating budget for the upcoming fiscal period. Staff developed the 2020-2021 proposed budget on the next page, which includes the current approved 2019-2020 budget.

The committee will discuss the proposed budget and revise as needed. The proposed operating budget will be presented for approval at the Finance Committee meeting held on April 8, 2020.

#### **EXPENSE and REVENUE BUDGET INCREASE/DECREASE:**

**Staff salaries/Employee Benefits & Payroll Taxes:** The budgeted amount of \$254,105 provides a 2% COLA for staff and a step increase for one position.

**Brokerage Fees:** The \$13,000 budget was decreased to \$5,000 since being released from the Title III grant. The Morgan Stanley Select UMA (Unrestricted) brokerage fees are accessed to the Foundation operating budget.

**Intrafund Transfers-Out:** The budget was decreased from \$31,500 to \$23,500 since being released from the Title III grant. The proposed 2020-21 amount of \$23,500 is for the annual scholarship banquet.

**District/Grant Contribution** – The district has permanently institutionalized the Foundation's Advancement Specialist position. The proposed budget amount for the position is \$70,690. In addition, the district will provide \$123,000 in direct operational support.
